## Tackling our Major Challenge

St Sylvester's GAA Club, Malahide urgently needs your help. Over recent years the club has built up a substantial debt in excess of €1.2m as it has developed the clubhouse in 2 Church Road and the playing facilities in Broomfield.



We must first eliminate our debts if we are to further develop the club playing and training facilities and retain for the community our superb club-house in the centre of Malahide village.

We are now asking our members and friends to become patrons of the club by making a donation to help with this challenge.

### Where your donation will go

Donations received in this appeal will be first used to reduce the loans the club has with its bank at present and then further develop our facilities.

### Tax Relief Scheme\*

The Finance Act 2002, introduced a scheme to provide tax relief for relevant donations to approved sports bodies for approved projects.

The club can claim a tax rebate on qualifying donations from PAYE tax payers. For example, a donation of €1,000 from a 41% tax payer could amount to a total benefit to the club of €1,695.\*

Donations from self-assessed tax payers can be offset so that a donation of €1,695 from a 41% tax payer would only cost the donor €1,000 once tax relief is claimed in their annual return.\*

### Donation Options

All donations to this debt-reduction appeal will be most welcome. The following are 2 suggested methods that you may wish to consider:

1. One-off Payment by cheque or credit card
2. Payment through a bank-loan scheme, where the club will receive the payment up front and the donor repays the loan over a longer term. (Details available on request).
